MOTION FOR SUMMARY JUDGMENT FILED BY PLAINTIFF/TRUSTEE LESLIE T. GLADSTONE

Tentative Ruling: The court will **hear** the matter. The court has reviewed Chapter 7 Trustee Leslie T. Gladstone's complaint, her motion for summary judgment, and the declaration concerning service of the motion. The court has received no opposition to the motion. That alone is sufficient cause to grant it. *See* CivLR 7.1(f)(3)(c). In addition and on the merits, the court finds that the Trustee is entitled to judgment as a matter of law on the legal analysis articulated in the Trustee's proposed order. But because Defendants' attorney refused personal service, paragraph J of the proposed findings of fact and conclusions of law now appears inaccurate. *See* ECF No. 19. The Trustee should come prepared to discuss amending this paragraph.
