2. **WITHIN FOURTEEN (14)¹ DAYS FROM THE DATE OF SERVICE THIS NOTICE**, you are further required to serve a copy of your DECLARATION IN OPPOSITION and separate REQUEST AND NOTICE OF HEARING [Local Form CSD 1184²] upon the debtor, counsel for the debtor (if any), and the Chapter 7 trustee, together with any opposing papers. The opposing declaration shall be signed and verified in the manner prescribed by Federal Rule of Bankruptcy Procedure 9011, and the declaration shall:

- a. identify the interest of the opposing party; and
- b. state, with particularity, the grounds for the opposition.

3. **YOU MUST** file the original Declaration and Request and Notice of Hearing with proof of service with the Clerk of the U.S. Bankruptcy Court at 325 West "F" Street, San Diego, California 92101-6991, no later than the next business day following the date of service.

IF YOU FAIL TO SERVE YOUR "DECLARATION IN OPPOSITION" and "REQUEST AND NOTICE FOR HEARING" within the 14-day¹ period, NO HEARING WILL TAKE PLACE, you shall lose your opportunity for a hearing and an order may be entered.
