**NOTICE OF OBJECTIONS TO DEBTOR'S CLAIM OF EXEMPTIONS

with specific reference to the following described property of this estate:

You are required to attach and serve declarations supporting your objections in accordance with LBR 9013-7(b)(1).

If you object to the proposed action:

1. **You are required** to obtain a hearing date and time from the appropriate Courtroom Deputy for the judge assigned to your bankruptcy case. Determine which deputy to call by looking at the Bankruptcy Case No. in the caption on Page 1 of this notice. If the case number is followed by the letters:

2. **Within fourteen (14)<sup>1</sup> days from the date of service of this motion**, you are further required to serve a copy of your **Declaration in Opposition to Motion** and separate **Request and Notice of Hearing** [Local Form CSD 1184<sup>2</sup>] upon the undersigned moving party, together with any opposing papers. The opposing declaration must be signed and verified in the manner prescribed by FRBP 9011, and the declaration must :

- a. identify the interest of the opposing party; and
- b. state, with particularity, the grounds for the opposition.

3. **You must** file the original and one copy of the Declaration and Request and Notice of Hearing with proof of service with the Clerk of the U.S. Bankruptcy Court at 325 West F Street, San Diego, California 92101-6991, no later than the next business day following the date of service.

**If you fail to serve your “Declaration in Opposition” and “Request and Notice of Hearing”** within the 14-day<sup>2</sup> period provided by this notice, **no hearing will take place**, you will lose your opportunity for hearing, and the objecting party may proceed to take the intended action.
