28 dischargeability of his debt against Michael Altinger, the debtor,


1 having been tried before the Court, and the Court having filed

12 calculated at 7% pursuant to Cal. Const. Art. XV, § 1, from  
13 February 7, 2002, until the date of this judgment.
