# Dear Leslie:

Thanks for the opportunity to support your actions on the Garden Fresh matter. Per our discussion, we have begun the process plotting out a schedule for both Phases of this program. This has included speaking with the former Distribution personnel on this project.

# 1. Phase I:

- a. Distribution Center Riverside, California
- b. Distribution Center Kennesaw, Georgia
- c. Food Processing Plant: Fullerton, California
- d. Storage Locations:
  - i. Houston, Texas
  - ii. Orlando, Florida
  - iii. Tempe (Phoenix), Arizona
- 2. Phase II: All Restaurant Locations (a subset of which have kitchen production operations)

#### Phase I Plan

We have outlined an action plan to attack all sectors above ASAP due to a number of factors, the primary ones being:

- Perishable Product: based on input from landlords and Garden Fresh Personnel, we believe there
  are perishable items in all groups above (with the exception of the Storage Locations but that needs
  to be validated).
- Marketplace Timing: Speed to Market is key given the estimated number of restaurants and others
  in their supply chain that are likely to never open again or close after a brief return (realizing that it
  is too challenging to operate). We believe the first mover action will get these inventories on the
  market.
- 3. Uncertain Marketplace: it is not clear what the values of these items will be given the chaos in the economy. However, moving fast will provide less competitive environment as we sell them.

Our current plan (pending your approval) is to have teams in the three key large facilities on Tuesday (tomorrow May 26, 2020) assuming there are no restrictions to access (i.e. keys, alarms, etc.). If we have issues with keys etc., we will deal with accordingly.

#### Phase I Timetable

The Planning Timetable for Phase I is as follows (consistent with our overall plan). Subject to change, but based on our communication, we assumed formal approval of our appointment on May 26, 2020.

1. Inventory Documentation: May 26-30, 2020

2. Announcement of Auctions via multiple channels: May 27, 2020

3. Auction Sites for reach of the Phase I Locations: May 27, 2020

4. Advertising and Promotion Launch: May 27, 2020 through Auction Closure

5. Auctions Live (post Court approval) target: June 1, 2020

6. Auction Period (varies based on Location): Week of June 1, 2020 – Week of June 22, 2020

7. Auction Closing & Collections Ten (10) to Fourteen (14) Days after Launch

8. Auction Pick – up Weeks of June 22, 2020 – June 30, 2020

# **Phase I Product Categories**

After careful review of the inventories provided and consideration of the depth and breadth of items available, we envision the following Auctions for each of the key locations as part of the program (for each of the Phase I, non-Storage Locations):

- 1. Production Equipment: Processing, Manufacturing and Food Handling
- 2. Warehouse and Handling Equipment
- 3. Office Furniture, Fixtures & Equipment
- 4. Inventory (auction for each category):
  - a. Small wares
  - b. Supplies
  - c. Food Dry/Canned
  - d. Food Refrigerated
  - e. Food Frozen

In speaking with the Head of Distribution, he is under the impression that much of the short code (shorter shelf life) items were disposed of. However, it was not envisioning that it would be two plus months dormant so there may be more items that are out of code or will be out of code at the conclusion of an auction.

#### **Phase II Restaurants**

Our plan for the restaurants would be to begin to gather data this coming week (upon approval by Court and Trustee Gladstone) with a plan to launch the first round of restaurants by the week of June 1, 2020. Given that there are markets with a higher concentration of locations we want to stagger the closure dates to maximize the bids and exposure of locations being auctioned.

It is a separate crew for these locations that will be handling (with a few exceptions). We have clustered the Restaurants geographically so that we can plan the data gathering and auction schedule methodically. This also assumes that we are able to quickly resolve any access issues (re-key locations) and perishable items that were not thrown away previously.

# **Phase II Restaurant Regions**

We have developed Sixteen(16) Clusters to allow staggered auctions where needed as follows:
